Call to Order

Andrew Lee, President called to order the regular meeting of the West Barnstable Civic Association at 7:02 PM.

Approval of Minutes

Approval of corrected January 3, 2023, meeting minutes Bob Stolte motioned; Dolores Schermer seconded. Unanimous vote taken to approve.

Report from Precinct 11 Councilor Kris Clark

Town and local updates:

On January 31st, I joined Judge Joe Reardon and others on his advisory committee to hear his updates. The Judge welcomed Ed Jay to his advisory committee. There has been some progress on the legal issues regarding the ownership of the land for purposes of receiving funding from the state for the restoration of the building and relocation of the box car to the museum's purpose, to benefit the request of the leadership of the Cape Cod Chapter, National Railway Historical Society.

Yesterday, I attended a meeting of the West Barnstable Water Commissioners. The Supervisor of the Hyannis Water Supply Division gave us an update on the town's plans to look for future potential water sources for the Town. He and the chair of the Hyannis Water Board planned to speak at the monthly meeting of the Town's Land Acquisition and Preservation Committee, which was canceled due to a cybersecurity threat on the Town's website on January 5, 2023. The presentation will be on the upcoming agenda at this month's LAPC's meeting, next Monday, February 13, 2023 at 5:30 PM. After a discussion, the WB Water Commissioners voted to send a letter of support for the purchase of the 18 acres of open space that is currently for sale adjacent to the Bridge Creek Conservation Area. It is zoned as Chapter 61B property, giving the Town the first right of refusal.

I researched with town staff and others and eventually supported the Form Based Zoning in Hyannis after making several amendments.

I was proud of the West Barnstable residents who came to the January WBCA meeting where the Town's planning staff hosted public input for the Town's Local Comprehensive Plan update. I was told that the meeting in West Barnstable was one of the best attended.
